

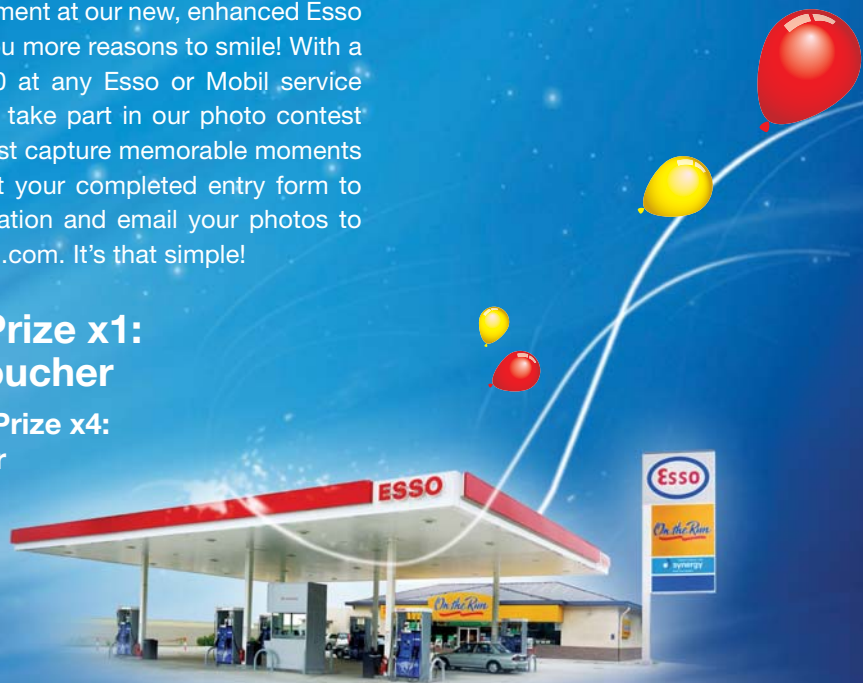

# 2010 "ON THE RUN MOMENTS" PHOTOGRAPHY COMPETITION

## TERMS AND CONDITIONS

1. This competition will be held as follows:
  - a. Date : March 6, March 13, March 20, March 27, April 3, April 10, April 17, 2010 (all the dates fall on a Saturday)
  - b. Venue : Participating Esso service stations (Please refer to participating station list)
  - c. Competition Time:
    - i. 10.00 a.m. to 12.00 noon - Registration
    - ii. 10.00 a.m. onwards - Competition begins
  - d. This competition is open to all Smiles Card members residing in Malaysia but excluding any employees, dealers of Esso Malaysia Berhad and ExxonMobil Malaysia Sdn. Bhd. and their affiliates in Malaysia, and their immediate families.
2. The theme of the photography competition is "On The Run Moments".
3. Entry forms must be submitted to the Official by 12.00 noon at the participating Esso service stations together with a minimum RM10.00 purchase receipt at any Esso or Mobil service stations.

  - c. Creativity
